

POLAND'S ACTIVITIES IN THE FIELD OF THE FIGHT AGAINST DOPING IN SPORT

- 1988: The Anti-Doping Commission, the first authority responsible for the fight against doping in Poland, is established
- 1990: Poland ratifies the Anti-Doping Convention of the Council of Europe (and, in 2004, the Additional Protocol thereto, which was open for signature in Warsaw)
- 1993: The Anti-Doping Commission is renamed the Commission Against Doping in Sport
- 1995: The Socio-Political Committee of the Council of Ministers adopts the National Programme Against Doping in Sport, the country's first strategic document on the fight against doping. The document focused on tasks in the field of education, doping controls and supervision over sanctions imposed by the Polish sports associations
- 2004: The Department of Anti-Doping Research of the Institute of Sport obtains WADA accreditation as an official anti-doping laboratory
- The Commission Against Doping in Sport (Polish NADO) becomes a signatory of the World Anti-Doping Code
- 2005: Poland hosts a monitoring visit of the Anti-Doping Convention of the Council of Europe
- 2006: Ratification of the International Convention against Doping in Sport by Poland
- 2007: Poland hosts an International Symposium of ANADO in Pułtusk
- 2012: The Department of Anti-Doping Research of the Institute of Sport is selected to carry out doping tests of samples during the UEFA EURO 2012 (as the only accredited laboratory)
- 2014: Poland's representative (Rafał Piechota) elected as Chair of CAHAMA
- 2015: Poland hosts a meeting of the *Ad Hoc Expert Group for Fair Trials of Council of Europe's Anti-Doping Convention* (Poland's representative Michał Rynkowski chairs the group)
- Poland hosts the 33rd meeting of the Council of Europe's Ad Hoc European Committee for the World Anti-Doping Agency (CAHAMA)
- Poland's representative (Rafał Piechota) is a member of WADA's Finance and Administration Committee for the period 2016-2019
- 2016: Minister of Sport and Tourism Witold Bańka supports the joint position of Ministers responsible for sport from 19 EU countries on the necessity to comply with anti-doping regulations and the need to protect "clean" athletes
- Poland hosts a monitoring visit of the Anti-Doping Convention of the Council of Europe
- The Council of Ministers approves the bill on the fight against doping in sport

Poland, Azerbaijan and WADA start cooperation on the development of an anti-doping system in Azerbaijan

Poland begins cooperation with Ukraine in the fight against doping in sport (the exchange of experience and experts)

Poland (the city of Katowice) expresses its interest to host the World Conference on Doping in Sport
